## **Voluntary Disclosure Programmes**

The Inland Revenue Authority of Singapore ("IRAS") has been actively conducting routine compliance checks, tax audits to ensure that individuals and companies are compliant with tax laws. The IRAS is empowered to impose penalties when there are errors, omissions and discrepancies. The penalties that the IRAS is empowered to impose under the relevant Tax Acts is dependent on whether there is evidence that indicates intention to evade taxes:

Without intention to evade	With intention to evade
1. Penalty of up to <b>200%</b> of the amount of tax undercharged	1. Penalty of up to <b>400%</b> of the amount of tax undercharged
2. Fine of up to <b>\$5,000</b> ; and/or	2. Fine of up to <b>\$50,000</b> ; and/or
3. Imprisonment of up to three years	3. Imprisonment of up to five years

To encourage taxpayers to be voluntarily compliant, the IRAS has the **Voluntary Disclosure Programme ("VDP")**. The purpose of the VDP is to encourage taxpayers to come forward voluntarily, in a timely manner, to disclose errors that have been made in their tax filings. In such cases, the IRAS is prepared to impose reduced penalties for voluntary disclosures subject to the fulfillment of qualifying conditions.

Income Tax (corporate and individual), Goods and Services Tax ("GST"), Withholding Tax ("WHT") and Stamp Duty are covered under the VDP.
